

Frequently Asked Questions regarding In-Person Counselling/ Document verification/ Hostel Allotment Scheduled during 07-09 Sep, 2022

SN	Question	Answer
1	Is document verification process compulsory?	Yes, document verification process is compulsory. You have been admitted provisionally during online rounds of counselling based on the information provided in the application form. This provisional admission will be confirmed only after the document verification.
2	The In-Person Counselling Schedule displayed on the website is on the basis of JEE Main – 2022 merit. My admission has been done on the basis of 10+2 PCM merit. At what date/time I should report for document verification/ hostel allotment?	<p><u>General Category (GENP/GENO)</u> In-Person counselling/Document Verification/Hostel Allotment will be done as per the schedule mentioned on the basis of JEE Main merit irrespective of whether the admission in the online counselling has been done on the basis of 10+2 PCM score or on the basis of JEE Main 2022 merit. If the JEE Main score of the candidate is less than 60 percentile and 10+2 PCM score \geq 70, he/she is required to report at 4:00 PM on Sep 09, 2022.</p> <p><u>Reserved Categories</u> Reserved category candidates are required to report for In-Person counselling/ Document Verification/ Hostel Allotment will be done as per the schedule mentioned below irrespective of whether the admission in the online counselling has been done on the basis of 10+2 PCM score or on the basis of JEE Main 2022 merit.</p> <p>PHP/PHO/JKS/NES/LUTS – 7 Sep, 2022 at 8:30 AM</p> <p>BC Punjab - 7 Sep, 2022 at 9:00 AM</p> <p>SCST/SCO/STO - 7 Sep, 2022 at 9:30 AM</p>
3	I am satisfied with my branch allotted on the basis of 10+2 PCM/ JEE Main – 2022 merit. I do not want any branch upgradation. When can I report for document verification/hostel allotment?	Document Verification/Hostel Allotment will be done as per the schedule mentioned on the basis of JEE Main merit even if you are not interested in any branch upgradation. If the JEE Main score of the candidate is less than 60 percentile and 10+2 PCM score \geq 70, he/she is required to report at 4:00 PM on Sep 09, 2022.
4	I was allotted a branch in the first/second round of counselling, but I didn't deposit the fee for that branch. Am I eligible for admission in this In-Person round of counselling?	Yes, your candidature will be considered for admission for the available seats on the basis of your JEE Main – 2022 merit.
5	I was allotted a branch in the first/second round of counselling, I deposited the fee for that. However, I have cancelled my admission and have applied for refund. Am I	

	eligible for admission in this In-Person round of counselling?	
6	I didn't get any branch in the first/second round of counselling due to low score. Am I eligible for admission in this In-Person round of counselling?	
7	How many seats are vacant in a branch?	Vacant seat status will be displayed on the website by 7:00 PM on 05-09-2022. Candidates reporting on 08-09th Sep, 2022 should check the availability of seats on 07th – 08th Sep, 2022 (9:00 PM) respectively before coming to the Institute.
8	I may not be able to attend this In-Person round of counselling. But I do not want to lose the opportunity of branch upgradation / Hostel allotment. Can I attend the counselling online? Or is there any alternative?	This counselling is being conducted in offline mode only. It is advisable to attend the counselling so that you can get the upgraded branch/ hostel, if available as per your merit. However, in case of emergencies, you can authorise someone to attend the counselling on your behalf.
9	Will there be any upgradation of branch on the basis of 10+2 PCM score?	As declared already on the website/advertisements, admissions for vacant seats (if any) in this round or in further rounds of counselling will be done based on All India rank (AIR) of JEE Main – 2022 only.
